# **WAFWA Monarch Working Group Charter**

#### v. March 8, 2018

### 1. Background

On June 20, 2014, President Obama issued a Presidential memorandum entitled "Creating a Federal Strategy to Promote the Health of Honey Bees and Other Pollinators" in response to the fact that there has been a significant loss of pollinators, including honey bees, native bees, birds, bats, and butterflies, from the environment. The memorandum specifically mentions the imminent risk of failed migration by the monarch butterfly, an iconic species well known and admired by the public. The memorandum created a Pollinator Health Task Force, charged with developing the National Pollinator Health Strategy. The Strategy, completed in May 2015, lays out current and planned Federal actions to achieve the overarching goals for honey bees, monarch butterflies, and pollinator habitat in general. The memorandum also directed federal entities to increase and improve pollinator habitat.

Both western and eastern populations of the monarch butterfly (*Danaus plexippus plexippus*) have shown significant declines since 1997. Based on those declines, the U.S. Fish and Wildlife Service (FWS) received a petition to list the monarch butterfly as threatened under the Endangered Species Act in the summer of 2014. FWS completed a 90-day finding in December of 2014 and determined that there was substantive information such that a 12-month species status assessment (SSA) should be conducted. The current deadline for publishing the FWS decision is June 30, 2019, with the SSA needing to be completed by late Fall 2018 in order to inform this decision. While FWS works on the SSA, they are encouraging that conservation of monarchs and their habitat proceed throughout the U.S. in hopes that the need to list will be prevented. The FWS and Midwestern Association of Fish and Wildlife Agencies (MAFWA) monarch coordinator reached out to the Western Association of Fish and Wildlife Agencies (WAFWA) to join them in working towards conservation of the monarch butterfly by taking up efforts in the west. WAFWA Directors responded by creating a new Monarch Working Group in July 2017.

# 2. Working Group Purpose

To identify and promote unified, ecosystem-based management approaches at the landscape-level for the western population of the monarch butterfly (*Danaus plexippus* plexippus), and pollinators in general, across all partner agencies.

### 3. Objectives

Conservation efforts for the monarch butterfly need to be formalized by fall 2018 in order to be considered in the SSA and the U.S. Fish and Wildlife Policy for Evaluation of Conservation Efforts (PECE) process. FWS will be collecting information on conservation efforts starting April 2018 using an on-line tool—the Monarch Conservation Database. While the Working Group is envisioned to support monarch and other pollinator conservation across the western states into the

foreseeable future, there is a need for near-term objectives that can be accomplished to address the short timeline for contributing to the SSA process in a meaningful way. Therefore, the Working Group has established several near-term objectives specifically to inform the SSA, including the development of a western Monarch Conservation Plan in 2018. Future objectives will focus on implementation of actions contained within the Conservation Plan with the long-term goal of improving status and maintaining persistence for the monarch throughout the western portion of the species range into the foreseeable future (50 years).

# Near-term objectives include:

- a. Work with western monarch experts to identify priority research, management, and conservation needs to address priority threats in the west (April 2018).
- Facilitate the capture of currently implemented and proposed western states monarch butterfly conservation efforts into the FWS Monarch Conservation Database (March -September 2018).
- c. Develop and present a draft outline of a Western Monarch Conservation Plan to the WAFWA Directors at the Annual Meeting, in Eugene, OR for their approval to proceed (July 2018).
- d. Present a final draft of a western Monarch Conservation Plan for approval by the WAFWA Directors at the 2019 Mid-Winter meeting in Tucson, AZ (January 2019).

#### Long-term objectives include:

- a. Identify and promote unified, ecosystem-based management approaches for the western population of the monarch butterfly (*Danaus plexippus plexippus*), and pollinators in general, across all partner agencies.
- b. Identify and promote conservation opportunities for the western monarch butterfly across state and federal boundaries, in accordance with the adopted Conservation Plan.
- c. Identify science and data gaps for western monarch butterfly conservation, and find and direct resources to fill those gaps.
- d. Facilitate conservation partnerships for western monarch butterfly management.
