Executive Summary

The 2012 Western Association of Fish and Wildlife Agencies—Administrative Officers Workshop and Conservation Business Managers Association (WAFWA-AOW/CBMA) Joint Workshop was held on September 30 – October 3, 2012, at the Holiday Inn in Cody, Wyoming. There were 99 attendees from the following states:

The meeting was opened on Monday morning with a speech by Scott Talbott, Director of the Wyoming Game and Fish Department and a video presentation about the Department was shown. Concluding the opening session, members had an opportunity to chose between three training sessions offered which included: Leadership Development by Bob Slade, President, RB Slade Associates, LLC; Marketing to Youth by Eric Keszler, Public Information Officer, Wyoming Game and Fish Department; or, Maximizing License Revenues by Rob Southwick, Southwick Associates, Inc.

- Discussion regarding the importance of the conference and the value of collaboration and shared knowledge. It was requested that each state emphasize that importance to their agency administration to assist in continued and growing attendance.
- Discussion regarding next year's (2013) conference in Wisconsin
 - Wisconsin is a CBMA state and therefore, signature authority of the WAFWA checking account will not be transferred. A seed check will be provide by Wyoming and the WAFWA checkbook will be sent directly to Alaska for their use in 2014.
- The 2014 conference will be held in Alaska and due to the high travel costs that will be required, it was proposed that a grant be established to absorb some of the impact to state budgets and incentivize participation.

- The format of the state reports will be modified pending additional coordination from a group of volunteers based on historic needs and usage of the document. The team will be comprised of; Greg Shehan from UT, Patrick Block from NM, Lizette Morgan from AZ and Patrick Cole from NE.
 - o Some items that were discussed for review, addition or modification include;

- Financial information be changed from the immediate fiscal year that has passed to the one prior, for example, the 2013 conference state report would require FY12 financial information be submitted;
- Request that states identify and include any pending fee adjustment information;
- States provide an approximate five-year trend of certification numbers
- Eliminate the research topic section;
- States provide an email roster identifying experts per technical area within their agency;
- States provide the number of FTEs and agency organizational charts;
- Revise questions to be very specific as to the request being made to alleviate multiple interpretations by states.
- It was also proposed that the report be sent to all 50 states requesting it be completed and returned.
