The Western Association of Fish and Wildlife Agencies (WAFWA) is an organization whose members are the state agencies with primary responsibility for management and protection of the fish and wildlife in 24 states and Canadian provinces, an area covering nearly 3.7 million square miles of some of North America's most wild and scenic country, inhabited by over 1,500 premier wildlife species. Its objectives are to cultivate friendly relations and mutual understanding among officials engaged in natural resources conservation and to coordinate the programs they administer. WAFWA also promotes public understanding and appreciation of the importance of conserving natural resources and encourages the management of fish and wildlife resources. The primary goal of the Student Engagement Program is to increase opportunities for professional engagement by embracing individuals with various lived experiences and perspectives, and by supporting student leaders who have had to overcome barriers. SEP is actively seeking fellows to participate in the annual Western Association of Fish and Wildlife Agencies' Summer Meeting on June 2-5, 2025, in Provo, Utah. During the WAFWA Conference, SEP will conduct a student workshop that will provide valuable career development information. Students will participate in discussions and gain information on selected topics relevant to seeking employment in the natural resource field. Applicant Criteria:

Member states/provinces in WAFWA include: Alaska, Alberta, Arizona, British Columbia, California, Colorado, Idaho, Kansas, Montana, Nebraska, Nevada, New Mexico, North Dakota, Northwest Territories, Oklahoma, Oregon, Saskatchewan, South Dakota, Texas, Utah, Washington, Wyoming, Yukon.

To be eligible to participate in this program, at the time of application you:

- Must be living in a member state, either as a current college student (undergraduate or graduate), or a recent graduate (within the last 12 months);
- Must be pursuing a degree in a natural resources or a conservation-related field or have a career interest in conservation and natural resources; including GIS, Human Dimensions, etc.
- Must be at least 18 years of age;
- Have a 2.4 (recommended) cumulative Grade Point Average.
